Approval of an amendment to the Fees and Rights Regulations of the Port Authority of Igoumenitsa S.A. (OLIG SA).

THE MINISTERS OF FINANCE - SHIPPING AND THE AEGEAN

Taking into consideration:

- 1. The provisions:

- c) Articles 41 and 90 of par. 63/2005 "Codification of the legislation on government and government bodies" (A 98) as amended and in force
- d) Article 21 "Breakdown of Port Funds Port Facility Conversion to S.A. legal form" Of Law 2932/2001 (A145), as amended and in force
- e) Article 6 of Law 2399/1996 "Port Charges" (A90), as amended and in force
- f) Article 1 of Law 4256 / 2014 (A92) 'Tourist vessels and other provisions'
- (g) of p.d. 125/2016 (A 210) "Appointment of Ministers, Assistant to the Ministers and Deputy Ministers"

- 5. The fact that this Decision does not entail expenditure in favor of the State budget, it is decided:
- A. The approval of the amendment of Article 4 of the Port Authority of Igoumenitsa (Decision 8122.1 / 50/2014 Government Gazette B 2747/2014) as follows:

ARTICLE 4A - RIGHTS OF ANCHORING (DOCKING), BERTHING AND MOORING OF PROFESSIONAL FISHING VESSELS WITHIN A PORT AREA OF COMPETENCE OF OLIG SA

Rights of anchoring (docking), berthing and mooring of professional fishing vessels within a port area of competence of OLIG S.A., shall be calculated as follows:

Length of vessel (m)	Anchoring (Docking) Fees	Berthing Fees	Mooring Fees
Professional fishing lengths up to 5 meters	€ 0.020 per meter of length per day	€ 0.024 per meter of length per day	€ 0.030 per meter of length per day
Professional fishing gear longer than 5 meters	€ 0.040 per meter of length per day	€ 0.048 per meter of length per day	€ 0.060 per meter of length per day

ARTICLE 4B - RIGHTS OF ANCHORING (DOCKING) AND SIDE-BERTHING OF RECREATIONAL VESSELS - PROFESSIONAL AND PRIVATE USE - SMALL VESSELS, PROFESSIONAL TOURIST DAY BOATS AS WELL AS TRADITIONAL VESSELS WITHIN A PORT AREA OF COMPETENCE OF OLIG SA

4.1 The following price table refers to the anchoring / docking fees of recreational vessels - for professional and private use - small boats, professional tourist day boats and traditional boats and applies during the months of May – June – July - August and September of each year.

The above prices do not include VAT.

4.2 During the months of April and October of each year, a discount of thirty per cent (30%) is granted in all categories of the price table.

- 4.3 During the months of November, December, January, February and March of each year, a discount of fifty per cent (50%) is granted in all categories of the price table.
- 4.4 During side-berthing, dock fees are increased by 70% in the months of May June July August September of each year.
- 4.5 Catamanar or Trimaran, whether privately or professionally, pays dock fees plus 30% only during the period May-June-July-August-September of each year.
- 4.6 For the provided facilities and services to the boats, the Port Authority of Igoumenitsa receives from the liable persons the corresponding dock dues and other rights (eg, provision of networks, etc.) provided in its invoice, as amended And is valid every time.
- 4.7 Docking charges shall be calculated according to the full length of the vessel, including any additions, platforms, etc.
- 4.8 Auxiliary boats or other floating means of docked boats as long as they are in the sea area of OLIG S.A. shall be charged with the corresponding charges.
- 4.9 The owner or the legal representative or the user of the vessel who is also liable with the ship-owner as principal is responsible for payment of the above fees and charges.
- 4.10 Docking charges for floating vessels shall be paid in advance upon arrival of the vessel and shall cover the agreed time period. The first day for calculating the payment of docking charges is the day of the 24-hour midnight on which the vessel sailed to the yacht shelter. The payment of dock dues will be paid in cash or by day check of a recognized credit institution in Greece.
- 4.11 In the event of deportation or abandonment for any reason of the post before the agreed time, OLIG S.A. is not required to return the prepaid charges.
- 4.12 Days of absence of boats from their berth are included in their agreed charging for the corresponding time of stay, in order for vessels to retain the docking rights. The charging of these vessels shall be interrupted only if OLIG S.A. is notified in writing by the owner or the master of the vessel that they do not wish to retain the right to dock and from the day of submission of the above written notice and thereafter.
- 4.13 Boats that remain at berths for more than one month must pay in advance at least every month and within the first five days of the berthing charges to qualify for the appropriate deduction

- 4.14 Those who have a permanent berth after approval by the competent Directorate of OLIG S.A. (after a decision by the Board of Directors) have to pay the annual docking fee until 30/01 of the current year in order to have the relevant discount (50%) on the general tariff.
- 4.15 The delay in payment of dock dues beyond 30 days automatically results in the loss of any vessel's docking rights, and OLIG S.A. has the right to discontinue any discounts granted to the vessel and to remove it from the OLIG's area of competence without absolutely Claim of his owner for compensation.
- 4.16 Vessels that depart, even temporarily, from the jurisdiction of OLIG S.A. must have repaid all debts at least until their day of departure, otherwise failure to pay all debts automatically entails the loss of any vessel's mooring right.
- 4.17 The delay in the payment of docking fees or other services entails the imposition of legal interest on late payments, irrespective of other sanctions that may be envisaged and / or legal actions (expulsion, seizure, etc.) in accordance with the legislation in force.
- 4.18 Professional ships calling in the area of competence of OLIG SA for a short stay to disembark or board passengers or use the facilities are obliged to pay a daily docking fee.
- 4.19 Athletic and other vessels / boats participating in athletic competitions shall be exempt from the prescribed loading fees during these races, in accordance with a certificate issued by the relevant Port Authority.
- 4.20 The Management of OLIG SA may request the payment of a guarantee, which shall remain in the competent financial department of OLIG and shall be refunded free of charge upon expiration of the porting agreement, provided that all the terms of that agreement have been met. The guarantee is in no way offset by fees or other liabilities.
- 4.21 Vessels are liable for the payment of any kind of contributions provided for by the provisions in force
- 4.22 Boatmasters are required to provide the shipping documents requested by OLIG S.A's officers.
- B. This Decision shall apply as from its publication in the Government Gazette.
