PASSENGER AND CRUISE PORT TARIFF

PASSENGER-VEHICLE TRANSIT,
ISPS CHARGES & SECURITY SERVICES,
PASSENGER TRANSPORT SERVICES,
PARKING

Effective from: 01.01.2025

PART A: TARIFF – DEFINITIONS AND TERMS

This issue defines the charges that will be attributed to IPA SA for the provision of services and the use of facilities at the Central Passenger Port of Igoumenitsa (domestic and international).

1. DEFINITIONS

Authorized third parties: Shipping Agents, Shipping Companies or any third parties entrusted with the collection and remittance of charges of this invoice.

ISPS Code: The International Ship and Port Facility Security Code of the International Maritime Organization (IMO).

Ship: Passenger/Car Ship of any type or Cruise ship or Pleasure Craft.

Central Passenger Port of Igoumenitsa: the relevant area and facilities, which are used to serve Ships, Passengers and Vehicles.

2. IMPLEMENTATION

The charges applied by IPA to Customers for Services provided by this or the use of Facilities are divided into the following categories:

- I. PASSENGER TRANSIT CHARGES
- II. VEHICLE TRANSIT CHARGES
- III. ISPS AND SECURITY AND SECURITY SERVICE CHARGES
- IV. BUS PASSENGER SERVICE CHARGES
- V. VEHICLE PARKING & UNACCOMPANIED CARGO

3. GENERAL

- 3.1 The charges mentioned in the invoices herein **not** include VAT unless expressly stated otherwise.
- 3.2 The authorized third parties collect and remit to the IPA the fees for transit, ISPS and guarding facilities in accordance with the applicable legislation.
- 3.3 The payer must pay the invoices issued by IPA SA and all rights, services provided and charges referred to in this Regulation / Invoice within thirty (30) days from the date of their issue unless otherwise stated in a signed agreement (replacement of paragraph 1 of article 14 of no. 8122.1/50/2014 joint ministerial decision – Government Gazette B.2747/2014).
- 3.4 Late payment surcharges: From the first working day of the month following the expiry of the deadline by which, according to the previous paragraph, the above rights, services and charges become due, late payment surcharges are imposed on them. The percentage of the late payment surcharge is set at five percent (5%) for each month of delay and the surcharge may not exceed two hundred percent (200%) of the debt due each time. If the late payment relates to a period of less than one month, an increase in late payment shall be calculated for the whole month. No surcharge shall be

calculated on the notional interest. (replacement of paragraph 2 of article 14 of Joint Ministerial Decision No. 8122.1/50/2014 – Government Gazette B.2747/2014).

- 3.5 IPA reserves the right to revise and change the tariff from time to time, with the obligation to give one month's notice for new services and two months' notice for price changes in existing charges.
- 3.6 The original text has been written in Greek and English and in case of conflict or discrepancy between the Greek and English versions, the Greek version will prevail over the English version.

PART B : INVOICE – FEES AND CHARGES

I. PASSENGER TRANSIT FEES (replacement of article 1 of no. 8122.1/50/2014 joint ministerial decision – Government Gazette B.2747/2014 – as amended by no. 3113.11/40369/2018 joint ministerial decision – Government Gazette B.2082/2018).

1. For every passenger embarking on or disembarking from any kind of vessel passenger ships, passenger -ferries with destination or coming from ports distant from the port of Igoumenitsa a distance of less than 125 nautical miles, a special fee is collected	0,80€
2. For every passenger embarking on or disembarking from any kind of vessel passenger ships, passenger -ferries with destination or coming from ports distant from the port of Igoumenitsa a distance of more than 125 nautical miles, a special fee is collected	1,70€
3. For each passenger participating in a daily – one-day cruise and / or in a daily sea trip / excursion a fixed fee is imposed	0,50€
4. For every passenger participating in a multi-day cruise, regardless of whether the cruise is limited only between Greek ports or extends to foreign ports, a fixed fee is imposed	1,70€
5. A fixed fee is charged for every passenger passing through "TRANSIT" at each Greek port of call. ("TRANSIT" means the passenger of a business passenger ship departing from a foreign port, who disembarks at one or more Greek ports, which calls at the ship, for a city tour and departs with the same ship after a short stay, which in total may not exceed 24 hours.)	1,00€

The following shall be exempt from payment of the fee:

- Toddlers up to one year old
- Passengers who are exempt from paying the fare when traveling by ferry and
- Passengers of private pleasure boats, small boats and professional pleasure boats.

II. VEHICLE TRANSIT FEES (replacement of article 2 of no. 8122.1/50/2014 joint ministerial decision – Government Gazette B.2747/2014 – as amended by no. 3113.11/40369/2018 joint ministerial decision – Government Gazette B.2082/2018).

a) Passage of Vehicles entering or leaving ships passenger ships, passenger -ferries with destination or coming from ports that are less than 125 nautical miles away from the port of Igoumenitsa.

For every vehicle entering or leaving any kind of vessel passenger ships, passenger -ferries with destination or coming from ports located less than 125 nautical miles from the port of Igoumenitsa, a special fee is collected as follows:

1. Passenger Vehicles	3,00€/vehicle
2. Trucks, vans and their trailers	1,00€ per meter
3. Buses and their trailers	0,60€ per meter
4. Motorbikes, Two-wheelers, three-wheelers regardless of cc.	1,10€/vehicle
5. Campers	3,20€/vehicle
6. Trailers or trailers from cars	1,00€ per meter

Public sector vehicles pay 25 % of the above special port fee of their respective category.

b) Passage of Vehicles entering or leaving vessels passenger ships, passenger -ferries, with destination or coming from ports that are more than 125 nautical miles away from the port of Igoumenitsa.

For every vehicle entering or leaving any kind of vessel passenger ships, passenger -ferries with destination or coming from ports distant from the port of Igoumenitsa a distance greater than 125 nautical miles, a special fee is collected as follows:

1. Passenger Vehicles	3,00€/vehicle
2. Trucks, vans and their trailers	1,00€ per meter
3. Buses and their trailers	0,60€ per meter
4. Motorbikes, Two-wheelers, three-wheelers regardless of cc.	1,10€/vehicle
5. Campers	3,20€/vehicle
6. Trailers or trailers from cars	1,00€ per meter

Public sector vehicles pay 25 % of the above special port fee of their respective category.

Each vehicle entering the port facility, regardless of whether or not it is boarded on board an vessel passenger ships, passenger -ferries, shall be subject to the above II.a and II.b vehicle transit charges for their respective category.

III. ISPS AND SECURITY AND SECURITY SERVICE CHARGES (replacement of article 6 of joint ministerial decision no. 8122.1/50/2014 – Government Gazette B.2747/2014)

A) ISPS CODE IMPLEMENTATION CHARGES

1. For every passenger embarking on or disembarking from any kind of vessel passenger ships, passenger -ferries with destination or coming from ports distant from the port of Igoumenitsa a distance greater than 125 nautical miles	2,50€
2. For each passenger participating in a multi-day cruise, if the cruise also covers ports far from the port of Igoumenitsa, a distance greater than 125 nautical miles	2,50€
3. For any kind of vehicle or unaccompanied cargo entering or leaving any kind of vessel passenger ships, passenger -ferries with destination or coming from ports distant from the port of Igoumenitsa a distance of more than 125 nautical miles	2,50€
4. For any type of ship falling within the scope of the ISPS Code within the boundaries of a port area, for each day indivisible, regardless of the number of calls made during the day.	250€/day

The following shall be exempt from payment of the fee:

- Toddlers up to one year old
- Passengers who are exempt from paying the fare when traveling by ferry and
- Passengers of private pleasure boats, small boats and professional pleasure boats.

(B) SECURITY AND CONTROL SERVICES OF FACILITIES OUTSIDE THE SCOPE OF THE ISPS CODE

For the safekeeping of facilities outside the scope of the ISPS Code and the general control of the security and movement of persons passing through these port facilities, a special charge of EUR 0.50 is imposed per passenger embarking on or disembarking from any kind of vessel passenger ships, passenger -ferries in an area outside the scope of the ISPS Code.

C) ADDITIONAL SECURITY FEE

If additional safekeeping of facilities or ships is requested by written request, for: Each extra guard per 8-hour shift indivisible: 150,00 €

The application must be submitted at least 72 hours before the provision of the service. Revocation of the request within 24 hours prior to the requested provision of service results in the imposition of the charge.

IV. BUS PASSENGER SERVICE CHARGES

For the transportation of passengers within the port facilities (from the Terminal to the ship and from the ship to the Terminal) by bus, a charge of 150€ per ship is charged to the shipping company for each mooring made for disembarkation / embarkation of passengers.

V. VEHICLE PARKING & UNACCOMPANIED CARGO

1. VEHICLE PARKING

The following charges apply per vehicle per undivided 24 hours.

2. Motorbikes, Two-wheelers, three-wheelers regardless of cc.	2,00€/vehicle
3. Passenger Vehicles	6,00€/vehicle
4. Trucks, vans and their trailers	10,00€/vehicle
5. Buses and their trailers	10,00€/vehicle
6. Camber, Trailers or trailers from cars	10,00€/vehicle

2 UNACCOMPANIED CARGO PARKING

The following charges apply for temporary storage per unaccompanied cargo per undivided 24-hour period:

- The first 24 hours after the unaccompanied cargo enters the special temporary storage area will not be charged.
- For the following 3 days, the charge will amount to a total of 15€ per day per unaccompanied cargo.
- For each day after the above period, the charge will be 30€ per day per unaccompanied cargo.

Any period of time shorter than a day will be charged as a full day.
